New England Equine Rescue - North, Inc. of West Newbury, Massachusetts is Accredited by Global Federation of Animal Sanctuaries



August 30, 2019, (West Newbury, MA) - The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Accredited status to New England Equine Rescue - North, Inc. as of August 23, 2019.

Accreditation signifies that New England Equine Rescue - North, Inc. (NEER-North) meets GFAS's rigorous and peer-reviewed equine care standards which are confirmed by a comprehensive site visit. Accreditation also signifies adherence to standards addressing the sustainability of the organization, ethical principles, finances, staffing, education outreach, security and safety and other operational aspects.

"We are proud to announce the Accreditation of New England Equine Rescue - North," said Valerie Taylor, GFAS Program Director-Equine. "The rescue employs commendable best practices when undertaking care, rehabilitation, and training for the equines, enabling the animals to then be placed in permanent, adoptive homes. In addition, NEER-North is run by a dedicated base of Board members and key volunteers who have a thorough background in, and understanding of, solid non-profit business practices, which has helped to provide a stable and sustainable footing for the rescue to operate on and increase capacity in a responsible fashion."
