Juliana's Animal Sanctuary Becomes the First Farm Sanctuary in South America to be Verified by Global Federation of Animal Sanctuaries



July 30, 2020 (Chia Cundinamarca, Colombia) - The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Verified status to Juliana's Animal Sanctuary (JAS) as of July 21, 2020.

Verification means that Juliana's Animal Sanctuary meets the criteria of a true farmed animal sanctuary and is providing humane and responsible care of the animals. To be awarded Verified status, an organization must meet GFAS's rigorous and peer-reviewed animal care standards which are confirmed by a site visit and they must also adhere to a demanding set of ethical and operational principles. The Verification status also provides a clear and trusted means for the public, donors, and grantors to recognize Juliana's Animal Sanctuary as an exceptional organization.

"We are very proud to announce the recent Verification of Juliana's Animal Sanctuary in Colombia," said Daryl Tropea Ph.D., GFAS Program Director. "They are the first farmed animal sanctuary to be certified by GFAS not only in Colombia, but all of South America. A variety of animals including cattle, pigs, rabbits, chickens, and goats have found lifelong homes here in the Andes mountains, after suffering neglect and abuse. Juliana and her team provide the highest quality of medical and daily care as well as promoting respect for all living beings with several advocacy campaigns. Providing vegan cooking workshops and distributing free vegan meals to people in Bogota is part of their outreach program to promote plant-based diets. Also, Juliana's Animal Sanctuary provides opportunities for visiting international volunteers and interns to learn more about the care of these wonderful animals."

"I had this urge," explained Juliana Castaneda Turner, Executive Director and founder of Julian's Animal Sanctuary, "to open a place like ours to help animals in this region of the world where animals are subject to unimaginable atrocities. Fifteen years ago, we started as a shelter, and more than nine years ago we became a Farm Sanctuary. The GFAS certification is so important, it is a guideline to continue assuring the best standard for animals, to improve, to grow, and educate in better ways. We have learned so much in the process. I thank the GFAS for always supporting, teaching, and guiding sanctuaries. This is a step forward for the liberation of animals in Colombia."
